4:30 PM: Awards Ceremony; door prize drawings. (You must be present to win.)

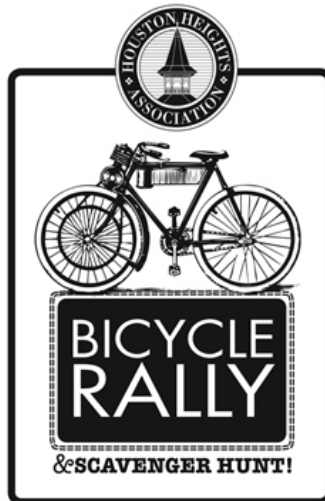
General Meeting

Director Election Schedule

Seven of the fifteen positions on the HHA Board of Directors will be filled by election over the next two months. Five positions are opening due to normal expiration of terms; members elected to these five positions will have three-year terms. Two positions are for the remaining final year of terms ended prematurely.

The five nominees receiving the highest numbers of votes will fill the three-year terms; the nominees receiving the sixth and seventh highest vote counts will fill the one-year vacancies. See the right column on this page for a list of current Directors and see page 3 for the 50-word campaign statements submitted by the candidates nominated at the September General Meeting.

The remaining schedule for the election of Directors to serve terms starting in 2013 will be as follows, in accordance with the By-Laws and Policies of the Association.

- October 8 at the General Meeting, nominees or their representatives may speak on their qualifications for 3 minutes. They will also draw for ballot positions at the beginning of the meeting.
- On or before the Friday following the General Meeting (October 12), the Election Committee will mail a ballot with a control number to each member in good standing whose dues are currently paid as of October 1. (Members invoiced by August 15 and not paid by October 1 are deemed not in good standing.)
 - Ballots must be *received* by November 10, at the close of the U.S. Post Office, with control numbers intact.
 - November 12, before the General Meeting, polls will be open for secret balloting in person from 6:00 PM to 7:00 PM *sharp*. The Election Committee will tabulate ballots and announce the results during the meeting. The results will also be published in the December newsletter.

Education Committee News

HHA Education Chair Stephanie Babb addressed the General Meeting on September 10, highlighting the committee's mission and focus on Search Institute's "40 Developmental Assets" (www.search-institute.org). Heights-area schools and programs the committee supports were discussed, along with current plans and a solicitation to the audience to submit ideas and suggestions for committee involvement.

The HHA Education Committee hosted its annual Principals' Welcome Back to School reception on Monday, September 24 at the Fire Station. With a robust turnout, the reception afforded Heights-area principals and committee members the opportunity to socialize and share collaborative ideas for the 2012-2013 school year.

The Holiday Story Contest will be held again this fall. Look for details in the November HHA newsletter, but for those of you who might want to share your holiday-themed story for judging, start those creative juices flowing! This year the contest will be expanded to include fourth- and fifth-graders in addition to middle and high school students and adults.

Heavy Trash Pick-Up Schedules Are Changing In November

Information provided by the City of Houston Solid Waste Department

Continuing its efforts to maximize cost savings, provide efficient service delivery, and engage in proactive customer service, the Solid Waste Management Department has taken your feedback and is improving your heavy trash (tree waste/junk waste) collection service.

Effective Thursday, November 1, 2012, the monthly heavy trash (tree waste/junk waste) pickup date for your neighborhood will change. Tree waste and junk waste collection will still occur in alternating months, odd-numbered months for tree waste (January, March, May, July, September and November) and even-numbered months for junk waste (February, April, June, August, October and December), but on the new heavy trash (tree waste/junk waste) pickup day designated for your neighborhood. Please note that collection day schedules for other Solid Waste services such as garbage, yard trimmings and recycling collection *will not* change.

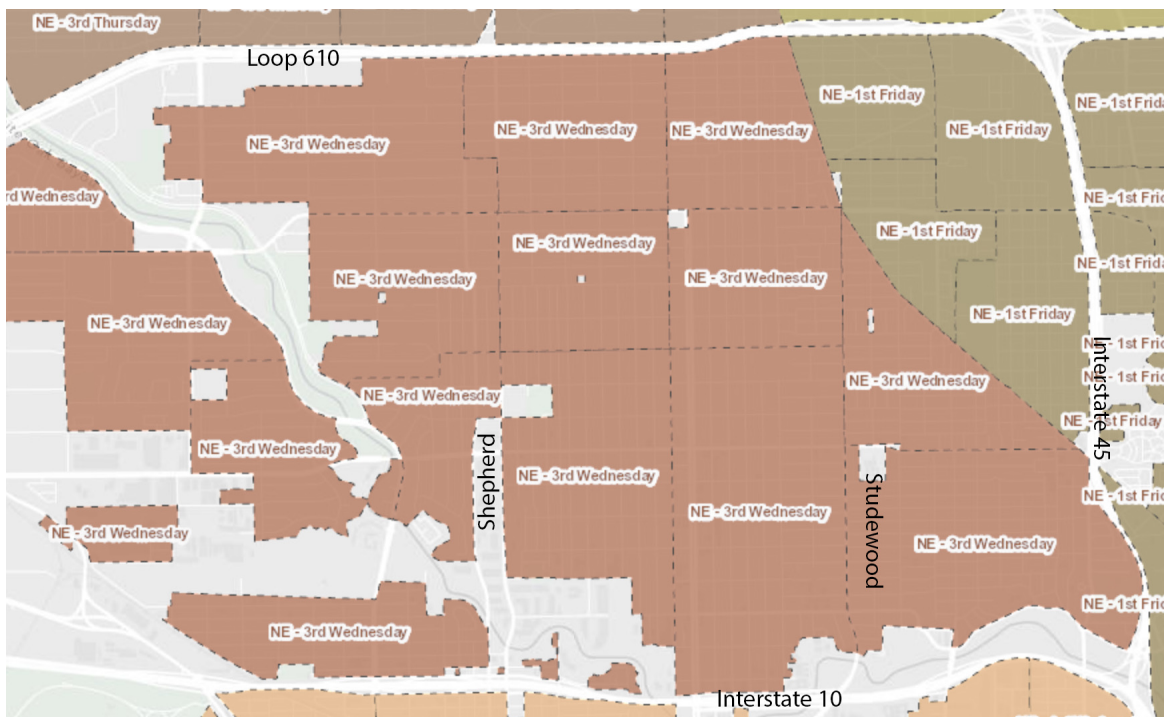
The service date change aims to achieve the following:

- Less confusion with neighborhood collection schedules
- A single service day for major community areas
- Easier to read/interpret service maps for customers and 311 operators
- Easier management of routes
- Budget savings in fuel and maintenance
- Greater availability for department support for community-based beautification projects

Remember, this change only affects your heavy trash (tree waste/junk waste) service day. [For most residents in the HHA service area, the new day will be the third Wednesday if we read the map correctly. –Editor]

Yale Street Bridge Load Limit Further Reduced by TxDOT

City of Houston Takes Proactive Steps to Monitor Bridge Usage

a message from the City of Houston

The Texas Department of Transportation (TxDOT) has reduced the load limit on the Yale Street Bridge just south of Interstate 10 from 8,000 lbs. per single axle to 3,000 lbs. per single axle. A standard passenger car with two single axles and a maximum weight of 6,000 lbs. (3,000 lbs. x 2 axles) would meet the new limit, but certain pick-up trucks and sport utility vehicles may exceed the new limit.

The change is not indicative of any recent deterioration in the bridge’s physical condition. It remains safe, but should be used within the new posted load limits. All required signs are now posted, north and south of the bridge, establishing the new load limit.

The Houston Public Works and Engineering Department is exploring options for additional signage to better notify motorists of the new limits. The Houston Police Department will continue to monitor traffic in the area to assure the load limits are enforced. Additionally, the City of Houston will, initially, monitor bridge traffic using a donated camera to assess compliance with the new limits.

The Yale Street Bridge is on a TxDOT prioritized list for statewide funding for replacement, with construction anticipated to start in late 2016. In the meantime, the Houston Public Works and Engineering Department will continue to routinely inspect the bridge for any change in conditions and intends to perform low-cost rehabilitative actions that will allow the bridge load restrictions to be raised back to those previously posted.

With the completion of Koehler between Heights and Yale, there is now an easy alternative route around the Yale Street Bridge via the Heights Boulevard Bridge for northbound and southbound truck traffic. The Heights Boulevard Bridge does not have load limits.
